1.	Welcome, minutes, actions and conflicts of interest	
	Jane Cummings welcomed members to the tenth meeting of the Board. The minutes and actions of the July SPB meeting were agreed as an accurate record of the meetings. There were no declarations of interest.	
	Jane Cummings thanked the SPB members who attended the Sharing Devolution Experiences from Greater Manchester –a session with Jon Rouse (Chief Officer) and noted that it was a useful session.	
	David Slegg provided an update from the London Estates Board:	
	 Sir Robert Naylor's estates work is aligned to the London Estates Board (LEB). He will attend future LEB meetings as a guest to update on progress with the work he will be leading in London. 	
	 The deadline for comments and feedback on London Health and Care Estates Strategy was 14th September 2018. The London Health and Care Estates strategy, along with the LEB gateway to phase 3 'shadow decision making' phase, will be paused until the NHSE/I Regional Director has been appointed. The launch of the strategy and progression of the LEB to phase 3 of will be aligned to the refreshed vision for London, The Long Term Plan and Social Care Green paper. 	
	Sam Everington noted that the Primary Care Strategy will be presented to the National Property Board on 19 th September 2018. This will be shared with SPB members on request.	
2.	Refreshing the vision for London -workshop	
	Vin Diwakar led the workshop, first reflecting on the journey London has been of in terms of partnership working and devolution; sharing feedback from discussions with individual members of the Board in recent weeks; and setting out the opportunity to refresh and deliver a collective vision for health and care.	
	There were two workshop sessions:	
	• Workshop A: A structured Polarity Mapping session was used to explore how some natural tensions, that underpin the partnership, manifest; and

how they can be used to harness different perspectives of the partnership, and diverse opportunities and constraints to achieve common aims.	
• Workshop B: Preparatory analysis, summarising the main themes from existing strategies and plans, was shared to frame a discussion on the barriers and enablers of transformation. This exercise identified some of the specific changes so that the SPB collective leadership creates the right conditions for the delivery of transformation plans across London.
