#### Introduction

- PCN pilot launched to improve cervical and breast screening uptake and coverage
- PCNs invited to bid for £16,000 over a calendar year to implement two evidence-based interventions to improve cervical and breast screening uptake and coverage
- 49 bids received and scored/evaluated by panel; 10 PCNs successful:

West Hill Health (West Kensington)	Springfield Park (City and Hackney)
Harrow East	Stepney and Whitechapel
North Camden	Streatham
Kentish Town South (Camden)	Beckenham
East Central Haringey	Chessington and Surbiton



### Timelines for pilots

- PCN pilots originally scheduled to run January to December 2020
- January March 2020: pilots start
  - Some are in planning stage
  - Some begin implementation of interventions
- March 2020: all pilots paused due to COVID-19
- July/August/September 2020: pilots re-start when local circumstances allow
  - PCNs asked to continue with cervical screening interventions but continue to pause breast screening interventions
- PCNs who did work on breast screening interventions in period January March 2020 'restart' in September 2020 (Chessington and Surbiton; Kentish Town; North Camden)
- November 2020: PCNs advised that breast screening interventions will not be restarted the pilots will be cervical screening interventions only

## Cervical screening intervention choices – detail

#### Extended access

- Early morning, evening and weekend appointments
- Online booking
- Learning disabilities
  - Understand the population, individual communication, case studies, pre-screening appointments
- Text message reminders
  - Text reminder of booked appointment the day before
- Non attenders
  - Those who do not book
  - Those who book but don't attend
  - Individual communication, case studies, survey and code responses
- Mobile number verification

#### Cervical screening intervention focus: Springfield Park

- City and Hackney PCN 3 GP surgeries
- Interventions: extended access and non-attenders
- Focussing specifically on the Orthodox Jewish community
- PCN call/recall team will call all those who did not attend booked appointments in 2020 and code responses – analyse this and investigate ways to widen access/uptake
- Also call those who attended their appointment January March 2020 and code responses

   what worked?
- Explore possibility of peer educators women who attended who can educate others on importance of screening



# Cervical screening intervention focus: Harrow East

- North west London PCN 3 GP surgeries
- Interventions: non-attenders, text reminders, mobile number verification
- Already doing extended access clinics and online appointments
- Mobile number verification sent an MJog message to all eligible women 78% numbers were correct. Remaining women will be called on other numbers held by the surgery to determine correct mobile number for woman or for household
- Investigating both non-attenders (those who booked but did not attend DNA) and decliners (never booked). Planning to send out a questionnaire and myth busters in various languages to these groups
- Engaging community champions in Somali and Romanian communities to increase screening and immunisation uptake



## Emerging good practice

- Every contact counts
  - Flag that patient is due cervical screen in system profile opportunity to mention to patient next time they contact the surgery (reception team and/or clinical team)
- Dedicated call recall resource
  - Gives time for personal contact with patients: reminder, discuss worries/fears, explain process/test, explain why it's important
- Engagement with importance of screening and implementation of interventions at every level in every practice – importance of clinical leadership and coordination
- Improved understanding of local population and their beliefs/challenges
  - Providing information in relevant languages for local population
  - Understanding barriers to access and attendance
  - Engaging community champions and peer educators



#### COVID-19 effects

- COVID-19 positive effects
  - Some PCNs report improvement in cervical screen uptake in 2020 despite COVID-19
  - Calling the night before for COVID-19 check – automatic reminder
  - Working from home available for weekday appointments
  - More aware/responsive to health issues

- COVID-19 negative effects
  - Staffing
    - Shielding/isolating/childcare
    - Fear
    - Bereavement
    - PPE
  - Some practices patients have left London
  - Perception that GP is closed/restricted access
  - Fear of attending health centres/fear of travel – particularly for BAME women



#### **Evaluation**

#### **Confounders**

- COVID-19 effects both positive and negative
- July 2020: all women in London who are due a cervical screen are now texted a reminder to book an appointment

#### Plan

- All interventions are evidence based evaluate pilots with a feasibility focus
  - Statement of feasibility, challenges, successes, key issues
- PCNs to provide uptake data, metrics on chosen interventions
- Case studies for implementation highlight the stages required to implement a particular intervention



## Next steps

- December 2020 update from each PCN pilot
- Possible early 2021 webinar with the 10 PCNs discuss progress, challenges, successes, learn from each other
- Pilots end during 2021 PCNs submit final reports
- Evaluation once all pilots finished
- Link pilot PCNs with others to advise on implementation of interventions to improve cervical screening
- Case studies webinar for London PCNs/GP surgeries, CCG cancer leads, cancer alliances
